Assignor further represents, warrants and covenants that it shall, upon Assignee's request, take all necessary steps, and shall execute, deliver and acknowledge, to Assignee any further instruments, which may be necessary to further the intent and purpose of this Assignment.

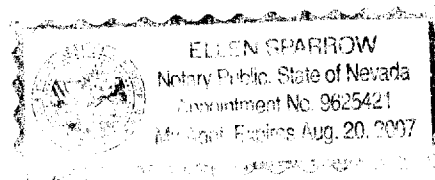
