Assignor hereby represents and warrants that it has the authority to make this Assignment; that it is the sole owner of all right, title and interest in and to the Marks, free and clear of any encumbrances; that it has the right to use without payment to any third party all of the Marks; and that it will not make or execute any commitment that may or will impair any of Assignee rights hereunder. Assignor further represents, warrants and covenants that it shall, upon Assignee's request, take all necessary steps, and shall execute, deliver and acknowledge, to Assignee any further instruments, which may be necessary to further the intent and purpose of this Assignment.
