

**RELEASE OF A SECURITY INTEREST
IN TRADEMARK COLLATERAL**

THIS RELEASE OF A CONTINUING SECURITY INTEREST IN TRADEMARK COLLATERAL (this "Release") dated as of September 30, 1994, is made by Heller Financial, Inc., a Delaware corporation ("Secured Party").
