GRANT OF SECOND LIEN SECURITY INTEREST

WHEREAS, OC WEEKLY MEDIA, Inc., a Delaware corporation (herein referred to as "Debtor"), owns all right, title and interest in and to the trademarks listed on the annexed Schedule A (the "Trademarks");

WHEREAS, Debtor is a party to that certain Credit Agreement dated December 20, 2004, by and between Debtor, as a Borrower, the other Borrowers referred to therein, NATIONAL CITY BANK ("National City"), as the Issuing Bank, a Lender and the Agent, and the other Lenders and Agents referred to therein (as may be amended, supplemented, restated or otherwise modified from time to time, the "Credit Agreement"); and

WHEREAS, pursuant to a Second Lien Security Agreement dated December 20, 2004 by and among Debtor, as a Grantor, the other Grantors referred to therein, and National City, as the Second Lien Agent (in such capacity, the "Second Lien Agent") (as may be amended, supplemented, restated or otherwise modified from time to time, the "Second Lien Security Agreement"), Debtor has granted to the Second Lien Agent, for the benefit of the Second Lien Secured Parties (as that term is defined in the Credit Agreement), a security interest in all right, title and interest of Debtor in and to the Trademarks, together with the goodwill of the business symbolized by the Trademarks and the applications and registrations thereof, and all proceeds thereof (the "Collateral"), to secure the payment, performance and observance of the Second Lien Secured Obligations (as that term is defined in the Credit Agreement).


NOW, THEREFORE, for good and valuable consideration, receipt of which is hereby acknowledged, Debtor does hereby grant to the Second Lien Agent a security interest in the Collateral to secure the prompt payment, performance and observance of the Second Lien Secured Obligations.

Debtor does hereby further acknowledge and affirm that the rights and remedies of the Second Lien Agent with respect to the security interest in the Collateral made and granted hereby are more fully set forth in the Second Lien Security Agreement, the terms and provisions of which are hereby incorporated herein by reference as if fully set forth herein.
