GRANT OF FIRST LIEN SECURITY INTEREST

WHEREAS, CITY PAGES MEDIA, Inc., a Delaware corporation (herein referred to as "Debtor"), owns all right, title and interest in and to the trademarks listed on the annexed Schedule A (the "Trademarks");

WHEREAS, Debtor is a party to that certain Credit Agreement dated December 20, 2004, by and between Debtor, as a Borrower, the other Borrowers referred to therein, NATIONAL CITY BANK ("National City"), as the Issuing Bank, a Lender and the Agent, and the other Lenders and Agents referred to therein (as may be amended, supplemented, restated or otherwise modified from time to time, the "Credit Agreement"); and

WHEREAS, pursuant to a First Lien Security Agreement dated December 20, 2004 by and among Debtor, as a Grantor, the other Grantors referred to therein, and National City, as the First Lien Agent (in such capacity, the "First Lien Agent") (as may be amended, supplemented, restated or otherwise modified from time to time, the "First Lien Security Agreement"), Debtor has granted to the First Lien Agent, for the benefit of the First Lien Secured Parties (as that term is defined in the Credit Agreement), a security interest in all right, title and interest of Debtor in and to the Trademarks, together with the goodwill of the business symbolized by the Trademarks and the applications and registrations thereof, and all proceeds thereof (the "Collateral"), to secure the payment, performance and observance of the First Lien Secured Obligations (as that term is defined in the Credit Agreement).


NOW, THEREFORE, for good and valuable consideration, receipt of which is hereby acknowledged, Debtor does hereby grant to the First Lien Agent a security interest in the Collateral to secure the prompt payment, performance and observance of the First Lien Secured Obligations.

Debtor does hereby further acknowledge and affirm that the rights and remedies of the First Lien Agent with respect to the security interest in the Collateral made and granted hereby are more fully set forth in the First Lien Security Agreement, the terms and provisions of which are hereby incorporated herein by reference as if fully set forth herein.
