RELEASE OF SECURITY INTEREST

THIS RELEASE OF SECURITY INTEREST (this "Release") is executed as of this 2nd day of July, 2004, by BANK OF AMERICA, N.A., formerly known as NationsBank of Texas, N.A., a national banking association in its capacity as collateral agent (the "Collateral Agent") for itself and each secured party to the Credit Agreement (the "Lenders").

WHEREAS, Personnel One, Inc., a Florida corporation (the "Borrower"), and the Collateral Agent entered into that certain Security Agreement dated as of October 30, 2000 (as amended through the date hereof and as further amended, extended, renewed, or restated from time to time, the "Agreement").

WHEREAS, in connection with the Agreement, the Borrower and the Collateral Agent entered into that certain Assignment of Security Interest in United States Patents and Trademarks (the "Trademark Assignment"), and Assignment of Security Interest in United States Copyrights (the "Copyright Assignment") both dated as of October 30, 2000 (and collectively referred to as the "Assignments").

WHEREAS, pursuant to the terms and conditions of the Assignments, the Collateral Agent was granted a security interest in all of Borrower's interest in the collateral more specifically described on Exhibit A attached hereto (the "Collateral").

WHEREAS, such Trademark Assignment was filed with the United States Patent and Trademark Office on December 22, 2000, and recorded against the trademark Collateral at Reel/Frame 002210/0354.

WHEREAS, such Copyright Assignment was filed with the Register of Copyrights on January 19, 2001, and recorded against the copyright Collateral at Volume/Page 3463/91.

WHEREAS, the Collateral Agent has received consideration for a full and complete release of the security interest in and liens in the Collateral, and now wishes to release such security interest and liens in the Collateral.

NOW THEREFORE, the Collateral Agent represents and agrees as follows:

1. The Collateral Agent hereby releases, cancels and terminates all of its right, title and interest in and to the Collateral, including its security interest in and liens on the Collateral and all other rights with respect to the Collateral, and conveys and assigns any and all right, title and interest that it may have in and to the Collateral to the Borrower.

2. The Collateral Agent represents that it has not exercised any of the rights with respect to the Collateral available to it under the Security Agreement. The Collateral Agent represents and warrants that it has not sold, licensed, conveyed or otherwise alienated any rights in and to the Collateral, and that it has not practiced or sublicensed any of the Collateral.

3. Without limiting the generality of the foregoing, this Release is intended to and shall forever terminate the irrevocable rights in the Collateral conveyed to the Collateral Agent and reconvey such rights to the Borrower.

IN WITNESS WHEREOF, the Collateral Agent has caused this Release to be duly executed by its officer thereunto duly authorized as of the date hereof.

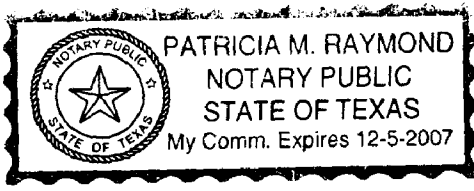
