SECURITY INTEREST IN TRADEMARKS

Reference is made to (i) that certain Pledge of Trademarks as Security dated as of June 15, 2001 and recorded at the United States Patent and Trademark Office at Reel 2796 and Frame 0259 on August 7, 2003 by and between Best Manufacturing Group LLC (f/k/a Best Textiles LLC) ("Best Borrower") and PNC Bank, National Association, as Agent for Lenders ("PNC") and that certain Pledge of Trademarks as Security dated June 15, 2001 and recorded at the United States Patent and Trademark Office at Reel 2796 and Frame 0271 on August 5, 2003 by and between Best Borrower and PNC (the "Best Security Agreement"); and (ii) that certain Security Agreement dated as of May 6, 1997 and recorded at the United States Patent and Trademark Office at Reel 1583 and Frame 0001 on May 8, 1997 by and between H.W. Baker Linen Co. Inc. ("Baker Inc. Borrower") and PNC and that certain Pledge of Trademarks as Security dated as of August 30, 2002 and recorded at the United States Patent and Trademark Office at Reel 2678 and Frame 0251 on February 26, 2003 by and between H.W. Baker Linen Co. LLC ("Baker LLC Borrower"); (Baker Inc. Borrower, Baker LLC Borrower and Best Borrower are, together, the "Borrowers") and PNC (the "Baker Security Agreement"); (Best Security Agreement and Baker Security Agreement are, together, the "Security Agreement")

Pursuant to the Security Agreement Borrowers granted to PNC a security interest in the Borrowers' right, title, and interest into the trademarks and registrations listed on Schedule A hereto (the "Trademarks").

PNC, in its capacity as agent for Lenders (the "Releasor") hereby re-assigns and releases to the Borrowers and terminates all right, title and interest that Releasor has in and to the Trademarks and all proceeds of the foregoing; and all general intangibles associated with the foregoing, including without limitation, all goodwill associated in any way with such Trademarks; the right to sue for past, present and future infringements, and all rights corresponding thereto associated with such trademarks.

This release shall be governed by and construed in accordance with the laws of the State of New York without regard to conflicts of law principles.
