**RELEASE OF SECURITY INTEREST IN  
TRADEMARK COLLATERAL**

This RELEASE, dated as of January <sup>25</sup> 2005, is made by SAPNA Debt Holding, LLC, a Delaware limited liability company in its capacity as the Administrative Agent (the "current Administrative Agent") in connection with the Credit and Security Agreement dated as of August 6, 1999 (the "Original Credit Agreement"), by and among, MELLON BANK, N.A. (the "Original Lender") and SPRING AIR PARTNERS – NORTH AMERICA, INC., a New Jersey corporation, SPRING AIR PARTNERS – NEW JERSEY, INC., a New Jersey corporation, SPRING AIR PARTNERS – PENNSYLVANIA, INC., a New Jersey corporation, SPRING AIR PARTNERS – CALIFORNIA, INC., a New Jersey corporation, CHATTAM & WELLS, INC., SPRING AIR CALIFORNIA – DELUXE BEDDING CO., INC., a New Jersey corporation, and CHATTAM AND WELLS MATTRESS COMPANY, L.L.C., a New Jersey corporation (individually, collectively, jointly and severally the "Grantors").

**W I T N E S S E T H**

WHEREAS, pursuant to the Original Credit Agreement and the Trademark Collateral Security Agreement by and among the Grantors and the Original Lender, dated August 6, 1999 (the "First Security Agreement") and recorded with the U.S. Patent and Trademark Office on September 30, 1999 at Reel/Frame No. 1971/0619, the Grantor granted the Original Lender a security interest in and to the trademarks and service marks in the United States or any state thereof; all goodwill symbolized by the trademarks and service marks; and all rights and interests pursuant to licenses or other contracts in favor of such Grantor pertaining to trademarks, service marks, trademark registrations, service mark registrations, trademark rights, or service mark rights (the "Trademark Collateral");

WHEREAS, pursuant to the Original Credit Agreement and the Amended and Restated Trademark Collateral Security Agreement by and among the Grantors and the Original Lender, dated September 20, 2000 (the "Second Security Agreement") and recorded in error as an assignment of ownership with the U.S. Patent and Trademark Office on October 25, 2000 at Reel/Frame No. 2179/0219, correction recorded on December 15, 2004 at Reel/Frame No. 2992/0025, the Grantor granted the Original Lender a security interest in the Trademark Collateral;

WHEREAS, pursuant to the Original Credit Agreement and the Amended and Restated Trademark Collateral Security Agreement by and among the Grantors and the Original Lender, dated September 28, 2000 (the "Third Security Agreement") and recorded with the U.S. Patent and Trademark Office on December 18, 2000 at Reel/Frame No. 2209/0968, the Grantor granted the Original Lender a security interest in the Trademark Collateral;

WHEREAS, pursuant to the Second Amendment to Amended and Restated Credit and Security Agreement (the "Amended Credit Agreement") by and among the Grantors and the Original Lender, dated April 18, 2002 and recorded with the U.S. Patent and Trademark Office on March 11, 2004 at Reel/Frame No. 2931/0859, the Original Lender assigned all liens and

security interests in the trademark collateral to The Provident Bank, an Ohio banking corporation (“Provident”) as the Administrative Agent;

WHEREAS, pursuant to the Amended Credit Agreement and the Assignment of Security Interest in Trademark (the “Assignment”) by and among the Grantors and Provident, dated March 9, 2004 and recorded with the U.S. Patent and Trademark Office on March 12, 2004 at Reel/Frame No. 2929/0530, Provident assigned its security interest in the trademark collateral to SAPNA Debt Holding, LLC, a Delaware limited liability company (“SAPNA”) as the current Administrative Agent;

WHEREAS, SAPNA acknowledges full payment, complete performance and satisfaction of all obligations pursuant to the Credit Agreement secured by the First Security Agreement, Second Security Agreement, and Third Security Agreement have been made;

WHEREAS, SAPNA acknowledges full payment, performance and satisfaction of the conditions set forth in the payoff letter by and between the Administrative Agent and the Grantor;

WHEREAS, each Grantor has requested that SAPNA release its security interest in the marks, as defined in the First Security Agreement, Second Security Agreement, and Third Security Agreement in connection with the termination of the Credit Agreement and the First Security Agreement, Second Security Agreement, and Third Security Agreement (the “Released Collateral”); and

WHEREAS, SAPNA hereby agrees and acknowledges the release of every security interest it received from the Original Lender and Provident and may have in the Trademark Collateral.

NOW, THEREFORE, in consideration of the foregoing, SAPNA hereby RELEASES, without recourse, all of its security interest in the trademarks and service marks, listed on Schedule A attached hereto and incorporated herein by reference and any other collateral described in the First Security Agreement, Second Security Agreement, and Third Security Agreement.

SAPNA agrees to provide the Grantor with any information and additional authorization necessary to effect the release of its security interest in the Released Collateral.
