Pursuant to the provisions of Article 4.04 of the Texas Business Corporation Act, Texas.net, Inc., a Texas corporation (the "**Corporation**"), adopts the following amendment to the Articles of Incorporation of the Corporation:

**FIRST**

The name of the Corporation is Texas.net, Inc.

**SECOND**

ARTICLE ONE of the Corporation's Articles of Incorporation is amended in its entirety to read as follows:


"The name of the Corporation is Data Foundry, Inc."
