ASSIGNMENT OF TRADEMARK

WHEREAS, ANSELL LIMITED, an Australian Company, Limited by Shares and having an address of Victoria Gardens, Level 3/678 Victoria Street, Richmond VIC, Australia 3121 ("Assignor"), has adopted, used and is using the trademark GAMMEX, which is registered on the Principal Register in the United States Patent and Trademark Office under the Registration Number 1,157,174 ("Mark"). NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged,



Assignor hereby sells, assigns, transfers and sets over to Assignee all right, title, and interest in and to the Mark, together with all of the goodwill of the businesses and business concepts symbolized thereby, as well as all registrations and applications and other rights, including common law rights, Assignor may have throughout the world with respect to such Mark.

2. Assignor hereby assigns, sells, transfers and sets over unto Assignee all claims for damages for reason of past infringement of the Mark, as well as the right to sue for and collect the same for its own use and enjoyment.

Assignor further authorize the Commissioner of Patents and Trade Marks of the United States and any official of any country or countries foreign to the United States whose duty it is to record trademark registrations, applications and title thereto, to record the Mark and title thereto as the property of Assignee, its successors, legal representatives and assigns in accordance with the terms of this instrument.

Assignee hereby accepts this assignment. Assignor will promptly transfer to or provide to Assignee copies of all files relating to the use, registration of, and applications for registration of, the Mark.


