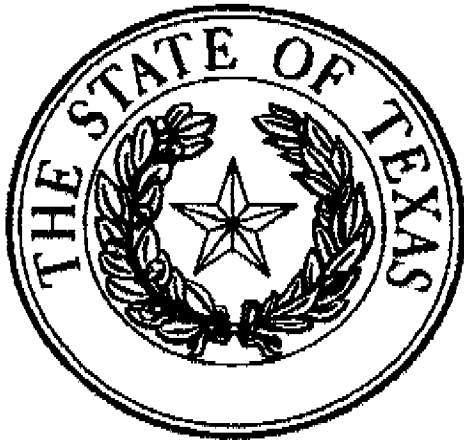

Pursuant to the provisions of Section 2.15 of the Texas Revised Limited Partnership Act (the "TRLPA"), and Article 5.18 of the Texas Business Corporation Act (the "TBCA"), the undersigned converting entity executes the following Articles of Conversion effective as of November 18, 2003:

1. A plan of conversion was approved and adopted in accordance with the provisions of Article 5.17 of the TBCA providing for the conversion of Daisy Brand, Inc., a corporation organized under the TBCA (the "Converting Entity"), to Daisy Brand, LP, a limited partnership organized under the TRLPA (the "Converted Entity"). A copy of the Certificate of Limited Partnership of the Converted Entity is attached hereto as Exhibit A.
2. An executed plan of conversion (the "Plan of Conversion") is on file at the principal place of business of the Converting Entity at 12750 Merit Drive, Suite 600, Dallas, Texas 75251, and, from and after the conversion, an executed Plan of Conversion will be on file at the principal place of business of the Converted Entity at 12750 Merit Drive, Suite 600, Dallas, Texas 75251.




