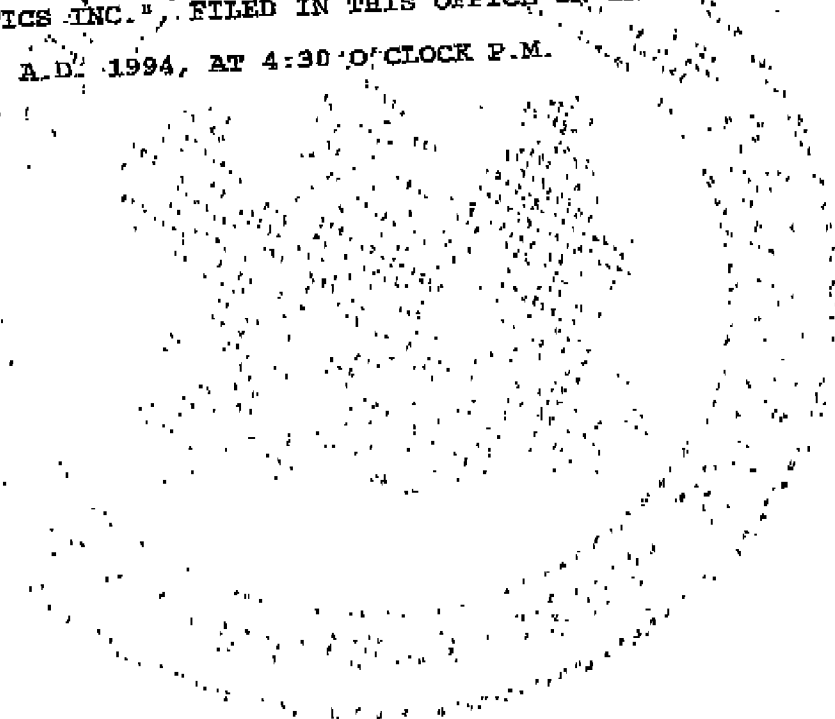

"1. The name of the corporation is "Cytte Plastics Inc."


**SECOND:** That thereafter, the stockholder of said corporation, by unanimous written consent, duly adopted the amendment.
