- the right to bring actions for past and future infringements or other violations of trademarks or copyrights or other rights therein, including the right to all revenues arising from any such action.

Assignor further agrees that it will, without further consideration, execute and deliver any and all documents reasonably necessary to effect the transfer, including, without limitation, any and all documents required to effect the assignment to Assignee of individual applications, or registrations, or renewals in any country where Assignor has existing applications, registrations, or renewals.
