RELEASE OF SECURITY INTEREST IN TRADEMARKS AND LICENSES

THIS RELEASE OF SECURITY INTERESTS IN TRADEMARKS AND LICENSES (this "**Release**") is made as of February 9, 2004 ("**Effective Date**") by and between Bank One N.A., successor-in-interest to The First National Bank of Chicago, a national association, with its principal office at Chicago, IL ("**Grantor**"), and Jason Incorporated, a Wisconsin corporation, with its principal office at 411 East Wisconsin Avenue, Milwaukee, Wisconsin 53202 ("**Grantee**").

WHEREAS, pursuant to the terms and conditions of that certain Amended and Restated Credit Agreement by and between Grantor and Grantee dated November 24, 1993 (the "**Trademark Security Agreement**"), Grantee granted to Grantor a continuing security interest in and to all of Grantee's right, title and interest in and to all of the trademarks, trademark applications, trade names, service marks, service mark applications, associated license agreements and related agreements (collectively, the "**Trademarks**"), including, without limitation, the United States trademark registrations, the United States applications for trademark registration, the foreign trademark registrations, the foreign applications for trademark registration, the unregistered trademarks, the trade names and assumed names and the license agreements set forth on Annex I attached hereto, in each case, together with the goodwill associated therewith;

WHEREAS, Grantor and Grantee entered into the First Amendment to the Trademark and License Security Agreement pursuant to the terms and conditions of that certain Amended and Restated Credit Agreement by and between Grantor and Grantee dated November 24, 1993 (the "**Security Agreement**");

WHEREAS, the Security Agreement was recorded with the United States Patent and Trademark Office ("PTO") on December 9, 1993, at Reel 1075, Frame 0205;

WHEREAS, Grantee has paid all of its outstanding indebtedness to Grantor.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Grantor hereby terminates the Trademark Security Agreement, and hereby terminates, cancels and releases any and all security interests it has against the Trademarks.

Grantor represents and warrants that: (i) it has the full power and authority to execute this Release; (ii) it has not assigned, transferred, restricted or otherwise encumbered any security interest it has against the Trademarks; and (iii) it has not recorded or otherwise evidenced its security interest with respect to any trademark, or registration of an application to register the foregoing, or any trade name or assumed name, other than those of the foregoing set forth on Annex I (attached hereto), in any jurisdiction throughout the world.

Grantor shall, at Grantee's expense, take all further actions, and provide to Grantee, its successors, assigns or other legal representatives, all such cooperation and assistance (including, without limitation, the execution and delivery of any and all documents or other instruments), reasonably requested by Grantee to more fully and effectively effectuate the purposes of this Release.
