For good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged by Reliant Building Products, Inc., a Delaware corporation (the "*Assignor*"), the Assignor has sold, conveyed, transferred and assigned to and vested in, and by these presents does hereby sell, convey, transfer, assign to, and vest in Alenco Holding Corporation, a Delaware corporation (the "*Assignee*"), and its successors and assigns forever, all of the Assignor's rights, title and interest, legal or equitable, in and to all of the assets, including, without limitation, accounts receivable, Debtor Actions (as defined in the Plan of Reorganization defined below), Debtor Action Recoveries (as defined in the Plan of Reorganization), cash, insurance policies and proceeds, and personal and real property and tangible and intangible property (collectively, the "*Assets*") that are used in its business conducted at the Assignor's facilities described on Schedule A attached hereto, all as such Assets exist at the close of business on the date of this Bill of Sale and Assignment.

TO HAVE AND TO HOLD the Assets unto the Assignee, its successors and assigns forever.

The Assets are being conveyed free and clear of all liens, claims, interests and encumbrances pursuant to and to the extent provided by that certain First Amended Joint Plan of Reorganization of Reliant Building Products, Inc., RBPI Holding Corporation, RBP of Arizona, Inc., RBP Custom Glass, Inc. RBP Fenesco, Inc., RBP Trans, Inc., RBP of Texas, Inc., Levan Builders Supply, Ultra Building Systems, Inc., Alpine Industries, CFA Holding Company, Care Free Aluminum Products, Inc. and Timber Tech, Inc. (the "*Plan of Reorganization*") and the order approving the Plan of Reorganization entered on March 15, 2001 by the United States Bankruptcy Court for the Northern District of Texas ("Bankruptcy Court") for the bankruptcy proceeding of Assignor administratively consolidated under Bankruptcy Case number 300-24446. This conveyance is made under an Asset Purchase and Sale Agreement dated as of April 12, 2001 (the "*Agreement*"), among the Assignor, Ultra Building Systems, Inc., Alpine Industries, Inc., RBP Trans, Inc., RBP of Arizona, Inc., CFA Holding Company, RBP Custom Glass Inc., Levan Builders Supply, Inc., Care Free Aluminum Products, Inc., Timber Tech, Inc., RBP of Texas, Inc., RBPI Holding Corporation, RBP Fenesco, Inc. and Alenco Holding Corporation, the parent corporation of the Assignee.
