**PLAN OF DISTRIBUTION**

THIS PLAN OF DISTRIBUTION (this "**Plan**") is adopted as of this 6<sup>th</sup> day of May, 2002 by Blue Armor International, Ltd., a Maryland corporation ("**Blue Armor**").

**BACKGROUND**

A. The board of directors of Blue Armor and its sole shareholder, Sermatech International Incorporated ("**Sermatech**"), have unanimously approved the dissolution of Blue Armor (the "**Dissolution**").

B. In connection with the Dissolution, Blue Armor desires to assign, convey, transfer and delivery to Sermatech any and all of the assets owned by Blue Armor as of the date hereof, including without limitation, those certain assets set forth on Schedule A to this Plan (the "**Assets**").

**AGREEMENT**

NOW THEREFORE, Blue Armor hereby agrees as follows:

1. Transfer of Assets. Effective immediately prior to the Dissolution, Blue Armor hereby assigns, conveys, transfers and delivers the Assets and all of Blue Armor's right, title and interest therein and thereto unto Sermatech and its successors and assigns.

2. Binding Effect. This Plan shall inure to the benefit of Sermatech and its successors and assigns and shall be binding upon Blue Armor and its respective heirs, estates, executors, personal representatives, successors and assigns.

3. Governing Law. This Plan shall be governed by and construed and enforced in accordance with the laws of the State of Maryland.
