SECURITY INTEREST RELEASE AND ACKNOWLEDGEMENT

RECITALS

A. The Provident Bank, an Ohio banking corporation having an address of One East Fourth Street, Cincinnati, Ohio 45202 (hereinafter "Provident"), and Blimpie International, Inc., a New Jersey corporation, having an address of 180 Interstate North Parkway, S.E., Suite #500, Atlanta, Georgia 30339, entered into a certain Loan Agreement and Patent, Trademark and License Security Agreement (hereinafter the "Loan Documents") giving rise to a purported security interest in the trademarks identified on the attachment hereto as Exhibit "A" (hereinafter, the "Blimpie Trademarks"), and such purported security interest was recorded in the United States Patent and Trademark Office on January 25, 2002 at Reel/Frame 2441/0563.

B. Provident assigned its purported security interest in the Blimpie Trademarks to The HillStreet Fund II, L.P. (hereinafter "HillStreet"), a limited partnership having an address of 300 Main Street, Suite 1C, Cincinnati, Ohio 45202, and such assignment was recorded in the United States Patent and Trademark Office on May 7, 2004, at Reel/Frame 2970/0617.

C. HillStreet wishes to fully release and discharge its purported security interest in the Blimpie Trademarks.

NOW, THEREFORE, for and in consideration of the mutual covenants contained herein and other good and valuable consideration, the receipt and adequacy of which are hereby acknowledged, HillStreet hereby agrees to the following:

1. HillStreet hereby releases any and all security interests, liens or other interests it may have in the Blimpie Trademarks.

2. HillStreet further acknowledges, agrees and recognizes that so long as the August 1, 1976 agreement between Blimpie International Inc. ("BI") and Metropolitan Blimpie, Inc. ("MBI") is not hereafter amended, in a writing signed by both BI and MBI, to provide or allow otherwise, HillStreet may not, cannot and shall not accept any hypothecation, interest, right, grant, lien or assignment of, in or upon the Blimpie Trademarks, or any trademark bearing BLIMPIE as an element, without (a) the prior written consent of both BI and MBI, or (b) a judicial determination, embodied in a final judgment (including any appeals), confirming a final award of an arbitrator in an arbitration commenced before the American Arbitration Association ("AAA") in the City of New York, pursuant to the terms of Paragraph 4 of the January 10, 2005 Settlement Agreement between MBI, BI, Provident and Hillstreet, before a single arbitrator in accordance with the Commercial Arbitration Rules of the American Arbitration Association, in which the arbitrator declares that HillStreet has the legal right and authority to accept such an interest.


