Assignor and Assignee acknowledge that Assignor has assigned certain of its other assets and liabilities to Assignee and that Assignee is the successor to that portion of the business of Assignor to which the mark VALIANT and the Application pertain.

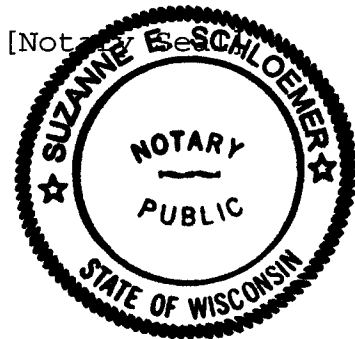
