**RELEASE OF SECURITY INTEREST IN TRADEMARKS**

**THIS RELEASE OF SECURITY INTEREST IN TRADEMARKS** (this "**Release**") is made as of January 28, 2005 ("**Effective Date**") by and between Bain/ACR, L.L.C., a limited liability company ("**Bain/ACR**"), with its principal office at 111 Huntington Avenue, Boston, Massachusetts 02199 ("**Grantee**"), and Anthony Crane Rental, L.P., a Pennsylvania limited partnership, with its principal office at 1165 Camp Hollow Road, West Mifflin, Pennsylvania 15122 ("**Grantor**").

**WHEREAS**, pursuant to the terms and conditions of that certain Memorandum of Trademark Security Interest by and between Grantor and Grantee dated June 4, 2002 (the "**Trademark Security Agreement**"), Grantor granted to Grantee a continuing security interest in and to all of Grantor's right, title and interest in and to all of the trademarks, and registrations of and applications to register the foregoing, and all of the trade names and assumed names owned by Grantor (collectively, the "**Trademarks**"), including, without limitation, the United States trademark registrations set forth on Schedule A attached hereto, together with the goodwill associated therewith;

**WHEREAS**, Grantor and Grantee entered into the Trademark Security Agreement pursuant to the terms and conditions of that certain Pledge and Security Agreement by and between Grantor and Grantee dated June 4, 2002 (the "**Security Agreement**");

**WHEREAS**, the Trademark Security Agreement was recorded with the United States Patent and Trademark Office ("**PTO**") on June 7, 2002 at Reel 2524, Frame 0001; and

**WHEREAS**, pursuant to the Grantor's confirmed chapter 11 plan of reorganization, Grantor's outstanding indebtedness to Grantee has been discharged as of the Effective Date.

**NOW, THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Grantee hereby terminates the Trademark Security Agreement and the Security Agreement, and hereby terminates, cancels and releases any and all security interests it has against the Trademarks.

Grantee represents and warrants that (i) it has the full power and authority to execute this Release and (ii) it has not assigned, transferred, restricted or otherwise encumbered any security interest it has against the Trademarks.

Grantee shall take all further actions, and provide to Grantor, its successors, assigns or other legal representatives, all such cooperation and assistance (including, without limitation, the execution and delivery of any and all documents or other instruments) requested by Grantor to more fully and effectively effectuate the purposes of this Release.
