TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARK RIGHTS

TERMINATION AND RELEASE dated as of January 3, 2005, from JPMorgan Chase Bank, N.A. (formerly The Chase Manhattan Bank), a New York banking corporation, as Administrative Agent (the "Administrative Agent") for certain banks and other financial institutions (the "Lenders"), to Informa Global Markets (US), Inc. (formerly McCarthy, Crisanti & Maffei, Inc.), a New York Corporation with its correspondence address at 110 Cedar Street, Suite 250, Wellesley Hills, Massachusetts 02481, Attention: Steven Konowitz (the "Grantor").

WITNESSETH:

WHEREAS, pursuant to the Credit Agreement, dated as of February 12, 1998, among the Grantor, Global Decisions Group LLC, the Lenders, the Administrative Agent and Bank of America National Trust and Savings Association, as Documentation Agent, (as amended, waived, supplemented or otherwise modified from time to time, the "Credit Agreement"), a security interest (the "Security Interest") was granted by the Grantor to the Administrative Agent in certain collateral, including the Trademark Collateral (as hereinafter defined);

WHEREAS, pursuant to that certain Trademark Security Agreement dated as of February 11, 1998, among the Administrative Agent and Grantor (the "Security Agreement"), Grantor, by reference to the Credit Agreement, reaffirmed its intent to grant a Security Interest to the Administrative Agent specifically in certain Trademark Collateral;

WHEREAS, the Security Agreement was recorded in the Trademark Division of the United States Patent and Trademark Office on January 4, 1999, at Reel 001836 and Frame 0937; and

WHEREAS, the Administrative Agent now desires to terminate and release the entirety of its Security Interest in the Trademark Collateral;

NOW, THEREFORE, for good and valuable consideration including the satisfaction of all obligations, indebtedness and liabilities secured by the Trademark Collateral pursuant to the Collateral Agreement, the receipt and adequacy of which are hereby acknowledged, and upon the terms set forth in this Termination and Release, the Administrative Agent hereby states as follows:


1. Definitions. The term "Trademark Collateral," as used herein, shall mean all of the Grantors' right, title and interest of every kind and nature as of the date hereof in the Trademarks (including, without limitation, those items listed on Schedule A hereto). The term "Trademarks" shall have the meaning provided by reference in the Collateral Agreement and the Security Agreement.

2. Release of Security Interest. The Agent hereby terminates, releases and discharges its Security Interest in the Trademark Collateral, and any right, title or interest of the Agent in such Trademark Collateral shall hereby cease and become void.

3. Further Assurances. The Agent hereby agrees to duly execute, acknowledge, procure and deliver any further documents and to do such other acts as may be reasonably necessary to effect the release of the Security Interest contemplated hereby.
