**TERMINATION OF SECURITY INTEREST
(Trademarks)**

This **TERMINATION OF SECURITY INTEREST**, dated as of August 2, 2004, is made by Wachovia Bank, National Association (successor to First Union National Bank), as Lender (the "Lender").
