NOTICE OF CHANGE OF OWNERSHIP INTEREST

NOTICE OF CHANGE OF OWNERSHIP INTEREST dated as of March 31, 2003, made by and among Time Warner Entertainment Company, L.P., a Delaware limited partnership ("TWE"), Warner Communications Inc., a Delaware corporation ("WCI") and E.C. Publications, Inc., a New York corporation ("E.C. Publications").

WHEREAS, DC Comics, a New York general partnership ("DC Comics") is the owner of the trademark registrations and applications listed on Schedule 1 attached hereto for the goods and/or services identified therein (the "Marks");

WHEREAS, as of March 30, 2003, TWE and E.C. Publications each held 50% of the general partnership interests of DC Comics (the "DC Comics Interests");

WHEREAS, pursuant to the Distribution Agreement, as amended by the Amended and Restated Distribution Agreement, dated as of March 31, 2003, by and among TWE, WCI and AOL Time Warner Inc. (the "Distribution Agreement"), TWE agreed to and did transfer to WCI its DC Comics Interests; and

WHEREAS, the parties wish to record the foregoing transfers with the United States Patent and Trademark Office so as to ensure a proper chain of title in the Marks;


NOW, THEREFORE, the parties agree as follows:

1. The parties hereby acknowledge that, pursuant to the Distribution Agreement, TWE transferred, assigned, and otherwise conveyed to WCI the DC Comics Interests held by TWE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, and all of TWE's right, title, and interest in and to each of the Marks; and


2. That as of March 31, 2003, DC Comics was, and is currently, a general partnership composed of E.C. Publications and WCI.

The parties have caused this Notice of Change of Ownership to be duly executed and authorized as of the date hereof.


