**RELEASE OF SECURITY INTEREST  
IN TRADEMARK COLLATERAL**

This RELEASE, dated as of February 4, 2005, is made by Fleet National Bank as successor in interest to The First National Bank of Boston ("First Boston") in favor of SC Licensing Corp. as successor in interest to SC Corporation d/b/a SC Direct (the "Borrower").

W I T N E S S E T H:

WHEREAS, First Boston was involved in a credit facility pursuant to which credit was extended to the Borrower, and in return the Borrower granted security interests pursuant to the following:

A Security Agreement dated March 12, 1997, between First Boston and SC Corporation d/b/a SC Direct, recorded with the U.S. Patent and Trademark Office on March 26, 1997, Reel/Frame 1569/0799.

WHEREAS, First Boston acknowledges full payment, performance and satisfaction of all obligations secured by the above-referenced Security Agreement; and


WHEREAS, the Borrower has requested that First Boston release its security interest in the collateral described in the aforementioned Security Agreement (the "Collateral").

NOW, THEREFORE, First Boston hereby **RELEASES** all of its security interest in the Collateral, namely, the trademark listed in Schedule A and the trademark registration listed in Schedule B, both schedules attached hereto and incorporated herein by reference, and any other collateral described in the aforementioned Security Agreement.

First Boston agrees, at the Borrower's expense, to cooperate with the Borrower and to provide the Borrower with the information and additional authorization necessary to effect the release of First Boston's security interest in the Collateral.
