TERMINATION AND RELEASE OF SECURITY AND PLEDGE AGREEMENT

This TERMINATION AND RELEASE OF SECURITY AND PLEDGE AGREEMENT, dated as of February 9, 2005 is made by JPMorgan Chase Bank National Association, successor by merger to JPMorgan Chase Bank, as Administrative Agent ("**Administrative Agent**"), having an office at 712 Main Street, Houston, Texas, 77002.

WHEREAS, Administrative Agent and QFH LLC, a Colorado limited liability company, having its chief executive office and principal place of business at 1475 Lawrence, Suite 400, Denver, Colorado 80202, and Canada Distribution, LLC, S&S Equipment Company LLC, International Food Distribution, LLC, US Fulfillment LLC, TQSC LLC, CLG Leasing, LLC, Quiz-Can Management, Inc., American Payroll Company, The Quizno's Master LLC, American Food Distributors LLC, American Freight Company LLC, Boulder Aviation Management LLC, Chain Management Systems LLC, CMS Agency LLC, CMS Gift Card LLC, Continental Lending Group LLC, QCCC LLC, Quiz-Dia LLC, Quiz-UK LLC, Quizno's Franchising LLC, Quizno's Services Company LLC, Seattle Area Directorship II LLC, Source One Systems LLC, The Quizno's Acquisition Company, The Quizno's Franchise Company LLC, The Quizno's Operating Company, LLC, and The Quizno's Realty Company LLC (collectively, "**Debtors**"), are parties to a Security and Pledge Agreement (the "**Agreement**") dated October 21, 2004, recorded on October 25, 2004, in the United States Patent and Trademark Office commencing at Reel No.2961, Frame No. 0743, whereby Debtor granted to Administrative Agent for the benefit of the Secured Parties a security interest in and to all of Debtor's right, title and interest of Debtor in and to the Collateral (as defined in the Agreement).

The Collateral includes the following **Intellectual Property**:

(A) **Patent Collateral**, meaning all Patents then owned or thereafter acquired by any Debtor, including each Patent Collateral identified in **Annex 1**. Patents are defined as (i) all patents and patent applications, including the inventions and improvements described and claimed therein, and all patentable inventions, (ii) all reissues, divisions, continuations, renewals, extensions and continuations-in-part thereof, and (iii) all rights, licenses and goodwill, now existing or hereafter coming into existence, (a) to all income, profits, royalties, damages and payments now or hereafter due and/or payable under and with respect thereto, including damages and payments for past, present or future infringements thereof, (b) to sue for past, present and future infringements thereof, and (c) otherwise accruing under or pertaining to any of the foregoing throughout the world; and

(B) **Trademark Collateral**, meaning all Trademarks then owned or thereafter acquired by any Debtor including each Trademark Collateral identified in **Annex 2**. Trademarks are defined as (i) all trade names, trademarks and service marks, logos, trademark and service mark registrations, and applications for trademark and service

mark registrations, (ii) all renewal of trademark and service mark registrations, and (iii) all rights (a) to all income, royalties, damages and other payments (including in respect to all past, present and future infringements) with respect to any of the foregoing (b) to sue for all past, present and future infringements thereof, and (c) otherwise accruing under or pertaining to any of the foregoing, together, in each case, with the product lines and goodwill of the business connected with the use of, and symbolized by, each such trade name, trademark and service mark.

Intellectual Property also includes (a) all inventions, processes, production methods, proprietary information, know-how and trade secrets; (b) all licenses or user or other agreements granted to any Debtor with respect to any of the foregoing, in each case whether now or hereafter owned or used, including the contracts, licenses, or other agreement with respect to the Patent Collateral or the Trademark Collateral; (c) all information, customer lists, identification of suppliers, data, plans, blueprints, specifications, designs, drawings, recorded knowledge, surveys, engineering reports, test reports, manuals, materials standards, processing standards, performance standards, catalogs, computer and automatic machinery software and programs; (d) all field repair data, sales data and other information relating to sales or service of products now or hereafter manufactured; (e) all accounting information and all media in which or on which any information or knowledge or data or records may be recorded or stored and all computer programs used for the compilation or printout of such information, knowledge, records or data; and (f) all causes of action, claims and warranties now or hereafter owned or acquired by any Debtor in respect of any of the items listed above.

WHEREAS, all terms used in this Termination and Release of Security Interest with initial capital letters that are not defined herein shall have the meaning set forth in the Agreement; and

WHEREAS, Administrative Agent now desires to terminate the Agreement and release and discharge all of the security interests granted in the Agreement as such interests relate in any way to the Collateral, including, without limitation, the Patent Collateral and the Trademark Collateral.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Administrative Agent hereby releases and discharges in its entirety all of its security interest in and to the Collateral, and reassigns, and transfers to Debtors all of its right, title and interest in and to the Collateral (collectively, the "Release"). Such Release shall include, without limitation, the Patent Collateral and Trademark Collateral. The Release shall be effective to the extent that the Agreement created a security interest in the Collateral, including, without limitation, the Patent Collateral and Trademark Collateral.

Administrative Agent shall take any actions Debtors may reasonably require to further effect this Termination and Release of Security and Pledge Agreement and any other documents or instruments as are reasonably necessary to evidence the termination and release of Administrative Agent's security interest granted in the Collateral

pursuant to the Agreement, provided any such action shall be at Debtors' sole cost and expense.

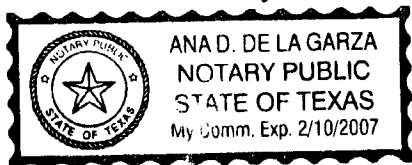
