PARTIAL RELEASE OF FIRST AMENDMENT TO GRANT OF  
SECURITY INTEREST IN PATENTS, TRADEMARKS AND LICENSES

THIS PARTIAL RELEASE OF FIRST AMENDMENT TO GRANT OF SECURITY INTEREST IN PATENTS, TRADEMARKS AND LICENSES (this "Partial Release"), dated as of August 13, 2004, is executed by The CIT Group/Commercial Services, Inc., a New York corporation ("Lender") in light of the following facts:

RECITALS

A. Gotcha International, L.P., a Delaware limited partnership ("Debtor") and Lender are parties to a certain First Amendment to Grant of Security Interest in Patents, Trademarks and Licenses, dated as of November 13, 2003 (the "First Amendment"), which was filed with the U.S. Office of Patents and Trademarks on January 21, 2004 at Reel/Frame 002899/0001, pursuant to which Debtor granted Lender a security interest in additional Intellectual Property Collateral referred to in such First Amendment, which includes various trademarks specified therein, as collateral security for the payment and performance of Debtor's obligations to Lender under that certain Term Promissory Note, dated as of November 13, 2003, made by Debtor in favor of Lender (the "Term Note").

B. Debtor and Lender inadvertently specified the wrong application number in the First Amendment with respect to one of the trademarks covered thereby, and wish to release the recording only against the incorrect trademark from the First Amendment as recorded in the records of the U.S. Patent and Trademark Office, so as not to impair the title of the owner of the "Gel Slick" mark, bearing application no. 75-025,910 and registration no. 2,236,994 (the "Incorrect Trademark"), which was the trademark incorrectly referred to in the First Amendment.

NOW, THEREFORE, Lender hereby releases the above referenced Incorrect Trademark from the First Amendment. Nothing contained in this Partial Release in any way releases or terminates the security interest claimed by Lender as to the other trademarks, now owned or hereafter acquired by Debtor, subject to the First Amendment.
