RECITALS

- A. Assignor and Assignee are Nevada corporations which are wholly owned subsidiaries of Circus Circus Enterprises, Inc., a Nevada corporation. The Boards of Directors of Assignor and Assignee are identical.
- B. Assignor has adopted the service mark EXCALIBUR (the "Mark") for hotel services and has used the Mark continuously since October 26, 1988. Assignor has registered the Mark in the State of Nevada and has filed Application Serial No. 73/766,304, dated November 29, 1988, to register the Mark in the United States Patent and Trademark Office.
- C. Since the opening of the Excalibur Hotel & Casino on June 19, 1990, Assignee has used the Mark at its location at 3850 Las Vegas Boulevard South, Las Vegas, Nevada, for hotel services. Use of the Mark by Assignee since that date has been with the consent of, and under the direct supervision and control by, Assignor and Circus Circus Enterprises, Inc. All quality standards for use of the Mark set by Assignor have been met or exceeded by Assignee.
- D. All uses of the Mark by both Assignor and Assignee have accrued to the benefit of Assignor. However, it has always been

the intention of Assignor and Assignee to have title to the Mark ultimately to be owned by Assignee, since subsequent to June 19, 1990 substantially all of the usage of the Mark has been made by Assignee, and use of the Mark by Assignor has been phased out. Therefore, the parties have agreed to assign all rights to the Mark effective as of the date of this Assignment.

Accordingly, pursuant to these recitals,

1. Assignor hereby assigns and transfers to Assignee all of its right, title, and interest in and to the Mark "EXCALIBUR", in any and all forms, for hotel services, along with the good will represented by the Mark.
2. This transfer shall include without limitation all rights to the Mark, including but not limited to all common law rights, state and federal registrations including application Serial No. 73/766,304, all rights to file and prosecute future applications to register the Mark, to defend opposition or cancellation proceedings, and to prosecute infringers.
