ASSIGNMENT OF TRADEMARK

Effective as of September 10, 2004, the undersigned, Sicus Products, Inc., a California corporation (hereinafter "Assignor"), for and in consideration of good and valuable consideration in hand paid, the receipt and sufficiency of which is hereby acknowledged, does hereby, assign, transfer and sell to Safety Tubs Holdings, LLC., a Delaware limited liability company (hereinafter called "Assignee"), all of Assignor's right, title and interest in and to the trademark application described below and all trademarks that issue therefrom, as follows:

Application No. 76/469,533, filed with USPTO 11.22.02, for the mark "Safety Tubs", Int'l Class 011: Bath Tubs; bath tub enclosures, together with all extensions, renewals, and amendments thereof, all income, royalties and other payments payable with respect thereto, the goodwill of the business symbolized by such mark, the right to conduct business under said mark, the right to sue for past infringement of said mark, all licensing and other use agreements related to said mark, and other worldwide rights related to the foregoing (hereinafter called the "Trademark").

This Assignment is executed in connection with and in consideration of the sale to Assignee, effective as of the date hereof, of the entire membership interest owned by Assignor in Safety Tubs, LLC, a Delaware limited liability company ("Safety Tubs"), together with the entire goodwill of Safety Tubs. Assignee hereby accepts the foregoing assignment and transfer of the Trademark.

Assignor represents and warrants that (i) Assignor is the sole owner of the Trademark, free and clear of all liens and encumbrances of any nature whatsoever; (ii) Assignor is duly organized and existing and has full power, right and authority to execute and deliver this Assignment, which has been duly executed and delivered, and (iii) no prior assignment or license has been granted in the Trademark except to Safety Tubs. Assignor covenants to protect the rights of Assignee in and to the Trademark transferred hereby against all claims by third parties.

Assignor hereby constitutes and appoints Assignee its true and lawful attorney, with full power of substitution, (i) to act in Assignor's stead with regard to the prosecution of application for registration of the Trademark; (ii) to execute any and all instruments, documents required in connection with such application; (iii) to defend the Trademark against all third parties; and (iv) to file any claim or take any other action or proceeding, either in its own name or in the name of Assignor or otherwise, which Assignee may deem necessary or appropriate to protect and preserve the right, title and interest of Assignee hereunder.

Assignor covenants and agrees that Assignor will promptly deliver to Assignee any documents, and take such action as requested by Assignee, to fully consummate the transfer embodied by this Assignment, including documents suitable for recording in the United States Patent and Trademark Office.

This Assignment and all representations and warranties, powers and rights herein contained or resulting herefrom are binding upon and shall inure to the benefit of the parties hereto and their respective successors, assigns and legal representatives. This Agreement may not be assigned by any party without the prior written consent of all parties.
