ASSIGNMENT NUNC PRO TUNC

WHEREAS, Diesel Engine Retarders, Inc. (hereinafter "Assignor"), a Delaware corporation, having a place of business at 16 West Main Street, Christiana, Delaware 19702, owns certain rights in the trademarks listed on Schedule A (hereinafter referred to as "Said Marks");

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, effective as of July 1, 2003, Assignor transfers and assigns unto Assignee all right, title, and interest in and to Said Marks and the registrations therefor, together with the goodwill of the business in connection with which Said Marks are used and which are symbolized by Said Marks, along with the right to recover for damages and profits for any and all past, present and future infringement thereof;



Assignor further agrees that said transfer includes the right, effective as of July 1, 2003, to bring in Assignee's own name, any protection, demand and/or cause of action for damages for unauthorized use or infringement of Said Marks.
