CERTIFICATE OF AMENDMENT  
TO THE  
CERTIFICATE OF INCORPORATION OF  
USC ACQUISITION CO.

Pursuant to Section 242 of the General Corporation Law of the State of Delaware (the "DGCL"), USC Acquisition Co., a corporation organized and existing under the laws of the State of Delaware, DOES HEREBY CERTIFY:

FIRST: The name of the corporation is USC Acquisition Co. (the "Corporation").

SECOND: Pursuant to a written consent of the Board of Directors of the Corporation, resolutions were duly adopted setting forth a proposed amendment to the Certificate of Incorporation of the Corporation, declaring the amendment to be advisable, and directing that said amendment be considered at a special meeting of the stockholders of the Corporation entitled to vote thereat called for such purpose. The resolutions approving the amendment are as follows:

RESOLVED, that it is advisable and in the best interests of the Corporation that the Certificate of Incorporation of the Corporation be amended by changing the Article thereof numbered "First" so that, as amended, said Article shall read as follows:

"The name of the corporation is Sola Custom Coatings Inc."

THIRD: That said amendment was duly adopted in accordance with the provisions of Section 242 of the DGCL.

FOURTH: This Certificate of Amendment to the Certificate of Incorporation shall be effective upon filing with the Secretary of State of the State of Delaware.
