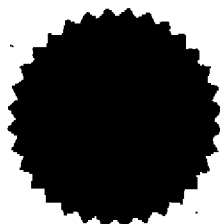

**Seventh:** The Trust agrees that it may be served with process in the State of Delaware in any action, suit or proceeding for the enforcement of any obligation of the LLC, irrevocably appointing the Secretary of State of Delaware as its agent to accept service of process in any such action, suit or proceeding. A copy of such process shall be mailed by the Secretary of State to the Trust at 126 Brookline Avenue, Boston, Massachusetts, 02215.
