### ARTICLES OF MERGER—DOMESTIC BUSINESS CORPORATION

In compliance with the requirements of 15 Pa.C.S. § 1926 (relating to articles of merger or consolidation), the undersigned business corporation, desiring to effect a merger, hereby states that:

1. The name of the corporation surviving the merger is:

ARNOLD TRANSPORTATION SERVICES, INC.

2. The surviving entity is a domestic business corporation and the address of its current registered office in this Commonwealth is:
