Whereas, Assignor is the owner of the trademark(s) as described in Exhibit A attached hereto and incorporated by reference herein (the "Mark(s)"); and


Whereas, Assignor wishes to assign his/her/its rights in the Mark(s) to Assignee.

ASSIGNOR'S REPRESENTATIONS:** Assignor represents and warrants (i) that Assignor is the exclusive owner of the Mark(s), (ii) that Assignor possesses all rights, title and interest in and to the Mark(s), (iii) that Assignor has the power to enter into this Assignment, (iv) that the Mark(s) do not infringe on the rights of any other person or entity, and (v) that the rights transferred in this Assignment are free of any lien, encumbrance or adverse claim.
- 3. CONTINUING OBLIGATIONS:** Assignor agrees to assist Assignee, upon request, by taking any reasonable action that may be necessary for the perfecting, securing and completing of this Assignment.
- 4. BINDING EFFECT:** The covenants and conditions contained in this Assignment shall apply to and bind Assignor and his/her/its heirs, legal representatives, successors and permitted assigns.
- 5. GOVERNING LAW:** This Assignment shall be governed by and construed in accordance with the laws of the State of Minnesota.
