



RELEASE OF SECURITY INTEREST IN TRADEMARKS

This release of security interest in trademarks (this "Release"), is made as of this 24th day of January 2005, by Bank of America, N.A., as successor by merger with Bank of America Illinois, in its capacity as the lender (the "Lender").

WITNESSETH:

WHEREAS, the Lender and Alpha Baking Co., Inc., an Illinois corporation (the "Borrower"), are parties to a Loan and Security Agreement dated as of April 17, 1996 (as it may be amended, restated, modified or supplemented from time to time, the "Loan Agreement"), pursuant to which the Lender has made loans to the Borrower in the amounts of up to \$22,500,000;

WHEREAS, Centurion Investment Associates, Ltd., an Illinois corporation (the "Grantor"), executed that certain Guaranty dated as of April 17, 1996 (as it may be amended, restated, modified or supplemented from time to time, the "Guaranty") in favor of the Lender whereby the Grantor guaranteed the full and prompt payment to the Lender of any and all liabilities under the Loan Agreement;

WHEREAS, the Grantor, to further secure the obligations of the Grantor under the Guaranty, did grant to the Lender a security interest in substantially all of the Grantor's assets, including, without limitation the trademarks and trademark applications of the Grantor;

WHEREAS, in order to evidence the security interest created in favor of the Lender, the Grantor executed that certain Trademark Security Agreement dated as of April 17, 1996 (the "Security Agreement") in favor of the Lender which Security Agreement was recorded on April 29, 1996 in Reel 1457, Frame 0690 of the United States Patent and Trademark Office; and

WHEREAS, the Lender agrees to release the lien and security interest created by the Security Agreement with respect to the trademarks identified in Exhibit A hereto.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency and adequacy of which are hereby acknowledged, the Lender hereby releases and discharges all liens, security interest, assignments and other rights, titles and interest held by the Lender in the trademarks of the Grantor which is described on Exhibit A, all reissues, continuations or extensions of the trademarks described on Exhibit A and all products and proceeds of the trademarks described on Exhibit A, including, without limitation, any claim by the Grantor against third parties for past, present or future infringement of any trademark described on Exhibit A, and which heretofore have been encumbered by the Security Agreement, from any and all such liens, security interests and assignments, and other rights, titles and interests.

This release shall be binding upon the Lender and the Lender's successors and assigns and shall inure to the benefit of the Grantor and the Grantor's successors and assigns, including, but not limited to, any present or future owner of any interest in the property identified in Exhibit A.
