RELEASE OF SECURITY INTEREST

This RELEASE OF SECURITY INTEREST, dated and effective as of February 16, 2005 (the "Effective Date"), by Fleet Capital Corporation ("Fleet"), grants a release of security interest to Cortz, Inc., d/b/a In the Swim ("ITS") as follows:

WHEREAS, ITS and Fleet entered into a Loan and Security Agreement, dated as of June 1, 1999, as amended, restated, or otherwise modified (the "Security Agreement"); and

WHEREAS, pursuant to the Security Agreement, ITS granted to Fleet a security interest in, and lien on, all right, title and interest of ITS in and to the trademarks identified on Schedule A hereto, including all goodwill connected with and symbolized by such trademarks (the "Trademarks"), which was recorded at Reel/Frame No. 1916/0916 with the United States Patent & Trademark Office on June 22, 1999 (the "1999 Assignment"); and

WHEREAS, effective October 15, 2002, ITS fulfilled its obligations and commitments to Fleet under the Security Agreement and Fleet has agreed to release its security interest in, and mortgage on, and assign to ITS any and all interest it may have in the Trademarks.

NOW, THEREFORE, for good and valuable consideration, receipt of which is hereby acknowledged:

1. Fleet acknowledges that it has released all of its liens upon, security interest in, and mortgage on, the Trademarks, and has assigned to ITS its entire right, title and interest, if any, in all Trademarks.
2. This RELEASE OF SECURITY INTEREST has been executed and delivered by Fleet for the purpose of releasing, removing, or otherwise eliminating the 1999 Assignment in favor of Fleet in the Trademarks that has been filed with the United States Patent and Trademark Office and, to the extent required, any other such offices in other countries of the world. All of ITS's obligations under the 1999 Assignment and the Security Agreement are thus terminated as of the Effective Date.
3. Fleet has a continuing obligation to sign all agreements, documents, or otherwise, necessary to carry out this RELEASE OF SECURITY INTEREST and the obligations herein.
4. This RELEASE OF SECURITY INTEREST shall be binding upon Fleet's legal representatives, successors and assigns.
