## CONFIRMATORY TRADEMARK ASSIGNMENT AGREEMENT

This CONFIRMATORY TRADEMARK ASSIGNMENT AGREEMENT (“ASSIGNMENT”), effective this 12th day of August 2004, is by and between WACHOVIA BANK, N.A., with offices located at 301 South College Street, Charlotte, North Carolina 28288 (“ASSIGNOR”) and AMERIPAY, LLC, a New Jersey limited liability company, with offices at 114 Essex Street, Rochelle Park, New Jersey 07662 (“ASSIGNEE”).

### RECITALS

A. ASSIGNOR, as successor to American Bank of Hollywood’s (“ABH”, a Florida Corporation) rights in and to, among other things, the trademark “AMERIPAY” and its associated goodwill, and including, without limitation, ownership of United States Patent and Trademark Office (“PTO”) Registration Number 1,972,887 for “AMERIPAY” (the “TRADEMARK ”), transferred all its rights in and to the TRADEMARK to ASSIGNEE for good and sufficient consideration (receipt of which is hereby confirmed and acknowledged) pursuant to an Assignment dated April 6, 1999, transferring the TRADEMARK to ASSIGNEE (the “1999 Assignment”, a copy of which is attached hereto).

B. The 1999 Assignment requires ASSIGNOR to execute without cost to ASSIGNEE any and all documents reasonably requested by ASSIGNEE that relate to the transfer of the TRADEMARK to ASSIGNEE.

C. ASSIGNEE has requested that ASSIGNOR execute this ASSIGNMENT which reasonably relates to the transfer of the TRADEMARK to it.

**NOW, THEREFORE**, in consideration of these premises and of the mutual promises set forth below and in the 1999 Assignment, which is herein incorporated by reference, and in consideration of the sum of \$100.00 paid by ASSIGNEE to ASSIGNOR in connection with the execution of this ASSIGNMENT, the receipt and sufficiency of which is hereby acknowledged by ASSIGNOR, the parties to this ASSIGNMENT acknowledge, covenant and agree as follows:

### ARTICLE I

1.1 ASSIGNOR acknowledges and covenants that as of the time the 1999 Assignment was executed, ASSIGNOR owned the TRADEMARK, and that, in particular, but without limitation, ASSIGNOR owned PTO Registration Number 1,972,887, as successor to ABH’s rights thereto.

1.2 ASSIGNOR confirms, acknowledges and covenants that it did, and ASSIGNOR hereby does, assign, transfer, set over, and deliver to ASSIGNEE all its right, title, and interest in
