Further, and without limitation, Spinglass assigns, sells and conveys to Freedom Fish, LLC any licenses or use agreements relating to the Trademarks, including, without limitation, that certain Trademark License Agreement between Free Range and Bama Sea Products, Inc. dated April 11, 2003. The term "Trademarks" means any and all of Assignor's trade names, trademarks, service marks, logos and design elements used in relation to Free Range's former Business (defined below), including, without limitation, the trademark set forth on Schedule A attached hereto and made a part hereof, and any and all derivations, variations and combinations thereof, all state, federal and international registrations and applications for registration related thereto, and all goodwill associated therewith. The phrase "Free Range's Business" means the business operated by Free Range under the name of Free Range Fish & Lobster at 450 Commercial Street, Portland, Maine 04101 location.


TO HAVE AND HOLD all and singular the aforesaid to Freedom Fish, LLC, its successors and assigns forever.


