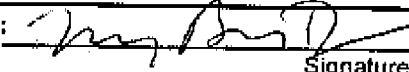

2. The Corporation is the owner of all of the outstanding shares of the stock of Mobeo, Inc., which is also a business corporation of the State of Delaware.
3. On November 13, 2001, the Board of Directors of the Corporation adopted the following resolutions to merge Mobeo, Inc. into the Corporation:

RESOLVED that the effective time of the Certificate of Ownership and Merger setting forth a copy of these resolutions shall be December 31, 2001.
