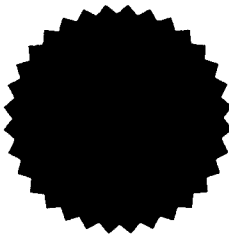

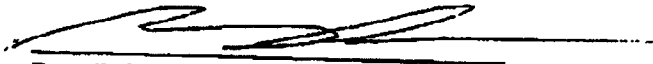
1. He is the duly elected and acting President of Cotagesoft, Inc., a Delaware corporation.
