## TRADEMARK ASSIGNMENT

2. Covenants.

(a) Assignors hereby covenant that they have the full right to convey the interest assigned herein, including, without limitation, the goodwill related thereto, free and clear of all known claims, liens and encumbrances, and will not take any action in conflict with this Assignment.

(b) Assignors further covenant and agrees that they will, without further consideration, execute and deliver any and all documents reasonably necessary to effect this transfer, including, without limitation, any and all documents required to effect the assignment to Assignee of individual applications, or registrations, or renewals in any country where Assignor has existing applications, registrations, or renewals.
