RELEASE OF TRADEMARK SECURITY INTEREST

THIS RELEASE OF TRADEMARK SECURITY INTEREST (the "Release") is dated as of December 31, 2004, and is made by Mizuho Corporate Bank, LTD., as successor by merger with The Fuji Bank, Limited, with a principal place of business at River Plate House, 7-11 Finsbury Circus, London, EC2M 7DH ("Mizuho"), as Security Agent for each of the Finance Parties (as such terms are referenced hereinbelow), in favor of Dometic Corporation, a Delaware corporation (formerly known as Erusiel Inc.) with the registered agent Corporation Service Company, 2711 Centerville Road, Suite 400, Wilmington, Delaware, 19808 ("Dometic").

RECITALS

A. Mizuho and Dometic, along with certain third parties, are parties to that certain Senior Facilities Agreement for Senior Secured Credit Facilities dated as of July 25, 2001 (the "Senior Facilities Agreement"), and that certain Loan Agreement for a Mezzanine Secured Credit Facility dated as of July 25, 2001 (the "Mezzanine Loan Agreement").

B. Pursuant to the Senior Facilities Agreement and the Mezzanine Loan Agreement, Dometic and Mizuho entered into that certain Security Agreement dated as of July 31, 2001 (the "Security Agreement"), and that certain Agreement (Trademark) dated as of July 31, 2001 (the "Trademark Security Agreement").

C. The Security Period (as defined in the Security Agreement and the Trademark Security Agreement) has expired.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties hereto agree as follows:

1. Pursuant to Section 22(f) of the Security Agreement and Section 4 of the Trademark Security Agreement, Mizuho, on its own behalf and as Security Agent for the Finance Parties (as such terms are defined in the Security Agreement and the Trademark Security Agreement), does hereby permanently and irrevocably release, terminate, discharge and cancel any and all of its security interests in, any and all of its liens on, and any and all other interests, of any kind or nature whatsoever, in, to or under, any and all right, title and interest of Dometic in and to the Trademark Collateral (as such term is defined in the Trademark Security Agreement) existing at any time, including without limitation those items of Trademark Collateral set forth in Exhibit "A" attached hereto.
