ASSIGNMENT OF TRADEMARKS

KNOW ALL MEN BY THESE PRESENTS, that JDM, Inc., a Pennsylvania corporation ("Seller") and Transcontinental Direct U.S.A. Inc. ("Purchaser"), a Delaware corporation, have entered into an Asset Purchase Agreement dated as of February 14, 2005, pursuant to which Seller agreed to sell and Purchaser agreed to buy substantially all of the assets of Seller (the "Agreement"). Except as otherwise stated herein, all terms used herein shall have the same meaning as set forth in the Agreement.

WITNESSETH:

WHEREAS, in accordance with the Agreement, Seller has simultaneously herewith by a bill of sale, assignments and other instruments of transfer and conveyance of even date vested in Purchaser all of Seller's right, title and interest in the Purchased Assets effective as of the Time of Closing including, without limitation, the trademarks and trademark applications which are pending and registered in the United States as listed on Exhibit A annexed hereto and made a part hereof (the "Trademarks"); and

WHEREAS, SELLER desires to assign to PURCHASER, and PURCHASER desires to acquire the entire right, title and interest of SELLER in the Trademarks and the issued registrations thereof, the whole in accordance with the terms of the Agreement.

NOW THEREFORE, in consideration of the mutual promises contained herein, and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, PURCHASER and SELLER agree as follows:

1. SELLER, by these presents, does sell, assign, and transfer unto PURCHASER its entire right, title and interest in and to the Trademarks, together with the good will of the Business symbolized by said Trademarks.
2. SELLER, at the expense of PURCHASER, agrees to execute all other instruments and take all other lawful actions necessary or appropriate to assist PURCHASER in securing and maintaining registered trademarks in the United States as PURCHASER shall reasonably designate, and to vest and confirm in PURCHASER legal title to the Trademarks and any and all causes of action at law or in equity for any and all infringement, dilution, or other unauthorized use of any of the Trademarks arising prior to the date hereof, and the rights to claim, receive and retain all monetary proceeds and other relief and benefits relating to those causes of action.
