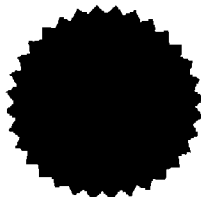

FURTHER RESOLVED, that for purposes of these resolutions, the term "proper officers of the Corporation" shall mean the President, any Vice President, the Secretary or the Treasurer of the Corporation, unless applicable statutes, rules or regulations applicable to the Corporation require action by a particular officer or officers of the Corporation, in which event the term "proper officers of the Corporation" shall be deemed to include any such officer or officers, and the action of any proper officer of the Corporation may be attested to by the Secretary of the Corporation.
