RELEASE OF LIEN IN TRADEMARKS

This RELEASE OF LIEN IN TRADEMARKS is given as of this 26th day of January, 2005 by JPMORGAN CHASE BANK, N.A. (formerly known as JPMORGAN CHASE BANK, which was formerly known as THE CHASE MANHATTAN BANK), located at 270 Park Ave., New York, New York 10017 (the "Assignor"), as Administrative Agent for the Lenders, in favor of GAB ROBINS NORTH AMERICA, INC., a Delaware corporation located at 9 Campus Drive, Parsippany, New Jersey 07054-4476 (the "Assignee"). Capitalized terms not otherwise defined herein have the meanings set forth (or incorporated) in the Collateral Agreement or the Trademark Security Agreement (as each is respectively defined below).

WHEREAS, pursuant to the Guarantee and Collateral Agreement, dated November 30, 1999, between Assignor and Assignee (as heretofore amended, supplemented or otherwise modified from time to time, the "Collateral Agreement"), Assignee assigned and transferred to Assignor and granted to Assignor, for the ratable benefit of the Lenders, a security interest in the Collateral, which included the Trademarks owned or at any time hereafter acquired by Assignee, or in which Assignee had or at any time acquired any right, title or interest, as collateral security, for the prompt and complete payment and performance when due (whether at the stated maturity, by acceleration, or otherwise) of Assignee's Obligations.

WHEREAS, pursuant to the Security Interest in Trademark Rights, dated November 30, 1999, between Assignor and Assignee (as heretofore amended, supplemented or otherwise modified from time to time, the "Trademark Security Agreement"), Assignee assigned and transferred to Assignor, and granted to Assignor, for the ratable benefit of the Lenders, a security interest in the Trademarks owned by Assignee, including the Trademarks listed in Schedule A, as collateral security for the prompt and complete payment and performance when due (whether at the slated maturity by acceleration or otherwise) of Assignee's Obligations.

WHEREAS, the Collateral Agreement was recorded in the United States Patent and Trademark Office on December 11, 1999, at Reel/Frame 2003/0738.

WHEREAS, Assignor has agreed to release its security interest in the Trademarks and assign, transfer, and grant all of its right, title and interest in the Trademarks to Assignee.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Assignor hereby releases its security interest in the Trademarks owned by the Assignee, including the Trademarks listed in Schedule A, and revests the Assignee with full right, title, and interest in the Trademarks.
