TRADEMARK ASSIGNMENT

WHEREAS, Constellation Concepts, Inc., a California corporation, having a principal place of business at 2200 Powell Street, Emeryville, California ("ASSIGNOR") owns certain right, title and interest in, to and under the trademarks and trademark applications set forth in the attached Schedule A (the "Properties"), and

WHEREAS, Tavistock Restaurants, LLC, a limited liability company organized and existing under and by virtue of the laws of the State of Delaware and having a principal place of business at 9701 Chestnut Ridge Drive, Windermere, Florida ("ASSIGNEE"), is desirous of acquiring such right, title and interest in, to and under the Properties.

NOW, THEREFORE, in accordance with and subject to the terms of that certain Asset Purchase Agreement dated September 5, 2003, among Assignor, CCRC Indiana, Inc. and Assignee, in consideration of good and valuable consideration, the receipt and adequacy of which is hereby acknowledged, the ASSIGNOR has sold, assigned, transferred and set over, and by these presents does hereby sell, assign, transfer and set over, unto the ASSIGNEE, its successors, legal representatives and assigns, all of its right, title and interest in, to and under the Properties, together with the goodwill of the business symbolized by the Properties, and the registration thereof, and further including: all income, royalties, and damages now and hereafter due and/or payable to ASSIGNOR, including without limitation, damages and payments for past or future infringements and misappropriations thereof, all rights to sue for past, present and future infringements or misappropriations thereof, and all rights corresponding to any of the above throughout the world;

AND THE ASSIGNOR HEREBY authorizes and requests the Commissioner of the United States Patent and Trademark Office, and any official of any country or countries foreign to the United States, whose duty is to issue trademark registrations or other evidence or forms of industrial property protection on applications as aforesaid, to issue the same to the ASSIGNEE, its successors, legal representatives and assigns, in accordance with the terms of this instrument; AND THE ASSIGNOR HEREBY covenants and agrees that the ASSIGNOR has full right to convey the interest herein assigned, and that the ASSIGNOR has not executed, and will not execute, any agreement in conflict herewith;

AND THE ASSIGNOR HEREBY covenants and agrees that the ASSIGNOR will execute, acknowledge, and deliver to ASSIGNEE, its successors, legal representatives and assigns, such other and further assignments, instruments, and documents as ASSIGNEE reasonably may request for the purpose of establishing, evidencing, registering, enforcing, or defending its ownership of all rights, titles, and interests in and to the Properties. ASSIGNOR constitutes and appoints ASSIGNEE as ASSIGNOR's agent and attorney-in-fact, with full power of substitution, to execute and deliver such assignments, instruments, and documents as ASSIGNOR may fail or refuse to execute and deliver, this power and agency being coupled with an interest and being irrevocable.
