This Certificate of Conversion to Limited Partnership, dated as of June 17, 2004, is being duly executed and filed by SE Communications GP Inc., as general partner, to convert Superior Essex Communications LLC, a Delaware limited liability company ("SE LLC") to Superior Essex Communications LP, a Delaware limited partnership (the "Limited Partnership"), under the Delaware Revised Uniform Limited Partnership Act (6 Del. C. §17-101, et seq.), and the Delaware Limited Liability Company Act (6 Del. C. § 18-101 et seq.). SE LLC was originally formed with the name Superior/Essex Corp., a Delaware corporation, which was the survivor in a merger with Superior Telecommunications Inc., a Georgia corporation, effective December 23, 1999 and changed its name to Superior Telecommunications Inc. (the "Original Entity"). The Original Entity's name was subsequently changed to Superior Essex Communications Inc., a Delaware corporation. The Original Entity was converted to SE LLC, a Delaware limited liability company and changed its name to Superior Essex Communications LLC.

1. The Original Entity was first formed on November 24, 1998. The jurisdiction of the Original Entity at the time it was formed was Delaware.
2. The Original Entity was converted into SE LLC on November 7, 2003. The jurisdiction of SE LLC at the time it was first formed was Delaware.
3. The Other Entity's name immediately prior to the filing of this Certificate of Conversion to Limited Partnership was Superior Essex Communications LLC.
4. The name of the Limited Partnership as set forth in its certificate of limited partnership is Superior Essex Communications LP.
5. The conversion of SE LLC to the Limited Partnership shall be effective on June 17, 2004.
