NOTICE OF RELEASE OF
SECURITY INTEREST IN TRADEMARKS

Reference is made to (i) that certain Trademark Security Agreement dated as of April 25, 2003 and recorded at the United States Patent and Trademark Office at Reel 2736 and Frame 0161 on May 19, 2003 by and between Galyan's Nevada, Inc. ("Nevada Borrower") and JPMorgan Chase Bank, formerly The Chase Manhattan Bank, as Collateral Agent ("JPMorgan") (the "Nevada Security Agreement"); and (ii) that certain Trademark Security Agreement dated as of May 3, 2001 and recorded at the United States Patent and Trademark Office at Reel 2295 and Frame 0865 on May 11, 2001 by and between Galyan's Trading Company, Inc. ("Trading Borrower") (Nevada Borrower and Trading Borrower are, together, the "Borrowers") and JPMorgan and that Trademark Security Agreement dated as of August 31, 1999 and recorded at the United States Patent and Trademark Office at Reel 1956 and Frame 0396 on September 9, 1999 by and between Trading Borrower and JPMorgan (the "Trading Security Agreement"); (Nevada Security Agreement and Trading Security Agreement are, together, the "Security Agreement").

Pursuant to the Security Agreement Borrowers granted to JPMorgan a security interest in the Borrowers' right, title, and interest into the trademarks and trademark registrations and applications listed on Schedule A hereto (the "Trademarks").

JPMorgan, in its capacity as agent for Lenders (the "Releasor") hereby re-assigns and releases to the Borrowers and terminates all right, title and interest that Releasor has in and to the Trademarks and all proceeds of the foregoing; and all general intangibles associated with the foregoing, including without limitation, all goodwill associated in any way with such Trademarks; the right to sue for past, present and future infringements, and all rights corresponding thereto associated with such trademarks.

This release shall be governed by and construed in accordance with the laws of the State of New York without regard to conflicts of law principles.
