The Chinet Company (the "Corporation"), a corporation organized and existing under and by virtue of the General Corporation Law of the State of Delaware, hereby certifies as follows:

**FIRST:** The Board of Directors of the Corporation by unanimous written consent pursuant to Section 141(f) of the General Corporation Law of the State of Delaware duly adopted resolutions setting forth a proposed amendment of the Certificate of Incorporation of the Corporation to become effective December 31, 1997 at 5:05PM, declaring said amendment to be considered by the stockholders of the Corporation. The resolution setting forth the amendment to the Certificate of Incorporation is as follows:

**'RESOLVED:** That it is advisable and in the best interest of the Company that the following resolution be submitted to the Company's stockholders for approval:

"That the First Article of the Certificate of Incorporation of the Company be amended to read as follows:

'1. The name of this corporation is The Chinet Company Manufacturing.'"
