

**CERTIFICATE OF AMENDMENT
OF
CERTIFICATE OF INCORPORATION**

Copperweld Corporation, a corporation organized and existing under and by virtue of the General Corporation Law of the State of Delaware,

DOES HEREBY CERTIFY:

FIRST: That the Board of Directors of said corporation, by the unanimous written consent of its members, filed with the minutes of the Board, adopted a resolution containing the following amendment to the Certificate of Incorporation of said corporation:

Article First of the Certificate of Incorporation, as amended, of Copperweld Corporation is hereby amended to read in its entirety as follows:

"FIRST: The name of the corporation is 001 Gateway Inc."

SECOND: That said corporation filed a Plan of Reorganization under Chapter 11 of the United States Bankruptcy Code which was confirmed by the U.S. Bankruptcy Court on November 17, 2003. The corporation filed bankruptcy on December 29, 2000, in the U.S. Bankruptcy Court for the Northern District of Ohio, Eastern Division.

THIRD: That in lieu of a meeting and vote of the stockholders of the corporation, such amendment of the Certificate of Incorporation of Copperweld Corporation was adopted pursuant to Section 303 of the General Corporation Law of the State of Delaware.

IN WITNESS WHEREOF, said Copperweld Corporation has caused this certificate to be signed by M. Dennis McGlone, its President and Chief Operating Officer this 9th day of December, 2003.
