CERTIFICATE OF AMENDMENT OF ARTICLES OF INCORPORATION OF


"Resolved that Article I. of the articles of incorporation of D B Enterprises, Inc. be, and the same hereby is amended to read as follows:


ARTICLE I

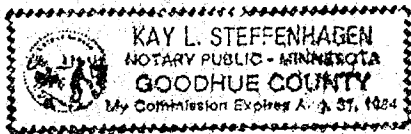
