RELEASE OF LIEN IN TRADEMARKS

This RELEASE OF LIEN IN TRADEMARKS ("Release") is given as of this 21 day of ~~June~~^{July} 2004 by PNC Bank, National Association ("PNC"), as Collateral Agent (as defined in the Trademark Security Agreement (as defined below)) for the Lenders (as defined in the Trademark Security Agreement) ("Assignor"), in favor of PriNexus, Inc. ("PriNexus"), a Delaware corporation ("Assignee").

WHEREAS, the Trademark Security Agreement was recorded in the United States Patent and Trademark Office on March 2, 2001, at Reel/Frame 002254/0585.

WHEREAS, Assignee has paid and performed in full all of its Obligations, and Assignor has agreed to release its lien and revest Assignee with full title to the Trademark Collateral.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Assignor hereby releases its security interest in, to, and under, and reverts Assignee with full title to, the Trademark Collateral, (including each Trademark set forth on Schedule A hereto), which security interest was granted pursuant to the Trademark Security Agreement recorded in the United States Patent and Trademark Office on March 2, 2001, at Reel/Frame 002254/0585.
